Sir,

As you may be aware, this Department implements the **PM-USP Central Sector Scheme of Scholarship for College and University Students** across the nation.

2. The National Scholarships Portal (<https://scholarships.gov.in>) is now live for applications from the students in higher education. **The allocated quota for your state is 2002 and in the last Academic Year i.e. 2023-24, only 70 fresh applications were received.** Students who were in top twenty percentile in higher secondary from your state board and annual income up to Rs. 4.5 lakhs are eligible to apply for this scholarship. Fewer applications from them will deprive the deserving students of your state from benefits of this Scheme.
