4. In case of any modification in specifications / terms and conditions / any clarification to the bid document, it will be hosted in the college website only and the bidders are requested to visit to our website from time to time and no separate corrigendum will be issued in this regard.
5. The rate should be exclusive of taxes and applicable tax should be clearly indicated.
6. Payments will be made on successful installation of the equipments.
7. The rates should be quoted along with supporting documents of specifications, technical features, list of users and authorized dealership documents (if applicable).
8. The College is exempted from paying Customs and Excise duty.
9. Proprietary items should be quoted with sole Manufacturer / Dealership certificate. Without dealership or manufacturer’s certificate no bids will be accepted.

11. Items of foreign origin should have insurance up to installation site.
12. If any item / equipment delivered in damaged condition, the equipment should be replaced with new one immediately.

14. The equipment will have to be installed by the supplier /Agent in the Department of Botany within 4 weeks, from the receipt of equipment, free of charges.
