## MEMORANDUM OF UNDERSTANDING (MoU)

This Memorandum of Understanding is made and executed on this day 21<sup>st</sup> of September 2021 between Goalpara Law College, having its registered office at Goalpara Law College, Goalpara-783121.

And

Goalpara College, Agia Road, Goalpara having its registered office at Goalpara Town, Agia Road, Goalpara, Assam - 783101.

## Purpose & Objectives:

The purpose of this MoU is to create a framework for collaboration between **Goalpara Law College** and **Department of English, Goalpara College, Goalpara** with the objectives as given below:

- a) To establish close linkage and functional coordination between **Goalpara Law College** and **Department of English, Goalpara College**.
- b) **English Departments of both the Colleges** will jointly organize Seminars, Workshops, Conferences, Symposiums & Competitions from time to time.
- c) **English Departments of both the Colleges** will jointly undertake Research & Project works in emerging areas with local relevance by the scholars/students and faculty members of the two Colleges.
- d) **English Departments of both the Colleges** shall facilitate their students for project works/exposure/workshop/student exchange programme trips as per convenience.
- e) **English Departments of both the Colleges** shall jointly conduct faculty exchange programme for sharing knowledge and gaining experiences.
- f) Apart from the aforesaid linkage **English Departments of both the Colleges** shall collaborate to organize extension and outreach activities like visit to national libraries, laboratories and conducting community programmes.

This MoU is valid for a period of three years from the date of signing of the MoU and can be extended for a period of two years on the recommendation of a review committee. The MoU will automatically lapse after three years, unless renewed.
